ELIGIBILITY

U.S. and foreign players: USTA age rules apply.

14 & under – Born in 2008 or 2009

12 & under – Born in 2010 or 2011

Players in the U12 boys and U12 girls must be 11 years by December 31, 2022 to play in the U12 division. No players under 11 will be accepted.

Players in the U14 boys and U14 girls must be 13 or 14 as of December 31, 2022.

ENTRY DEADLINE - OCTOBER 17, 2022

Both entry forms and fees must be received by October 17. No late entries will be accepted. All withdrawals must be submitted in writing.

Entry Fee: The entry fee is \$145 (U.S. dollars drawn on U.S. banks) and includes a T-Shirt. No phone or fax entries will be accepted.

THERE WILL BE A FEED-IN CONSOLATION THROUGH THE QUARTER-FINALS FOR ALL DIVISIONS.

There will be a 3rd and 4th place playoff. Play is expected. Awards will be given.

RULES AND REGULATIONS

- Two matches per day may be scheduled. Night play and a third match in one day may become necessary. Play will be 2 out of 3 sets in the main draw. The qualifying draw and the feed-in consolation will play a match tie break if a third set is needed. The Twelve Point Tiebreaker will be used in all sets, except for the feed-in consolation, and qualifying draw third set. Scoring and sites may be changed due to weather conditions.
- The U.S.T.A. Point Penalty System will be enforced. Five-minute warm-up, including practice serves will be allowed. A ten-minute break is allowed between second and third set, and a new can of balls will be used for the third set. Default time is 15 minutes.

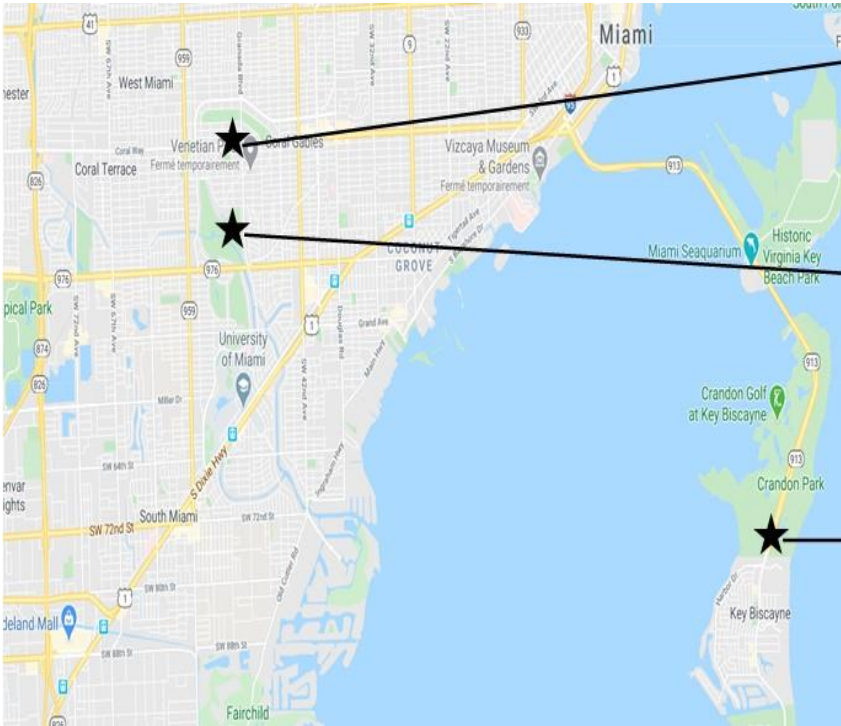
